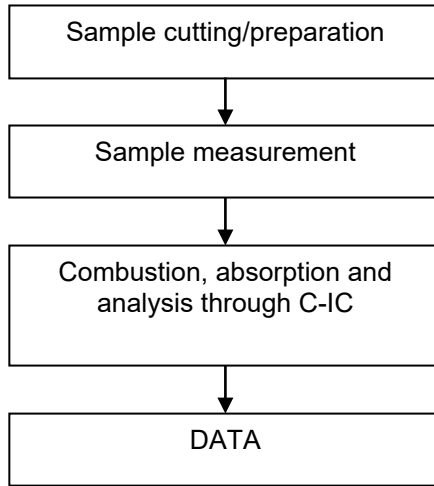

Halogen-CIC Testing Flow Chart



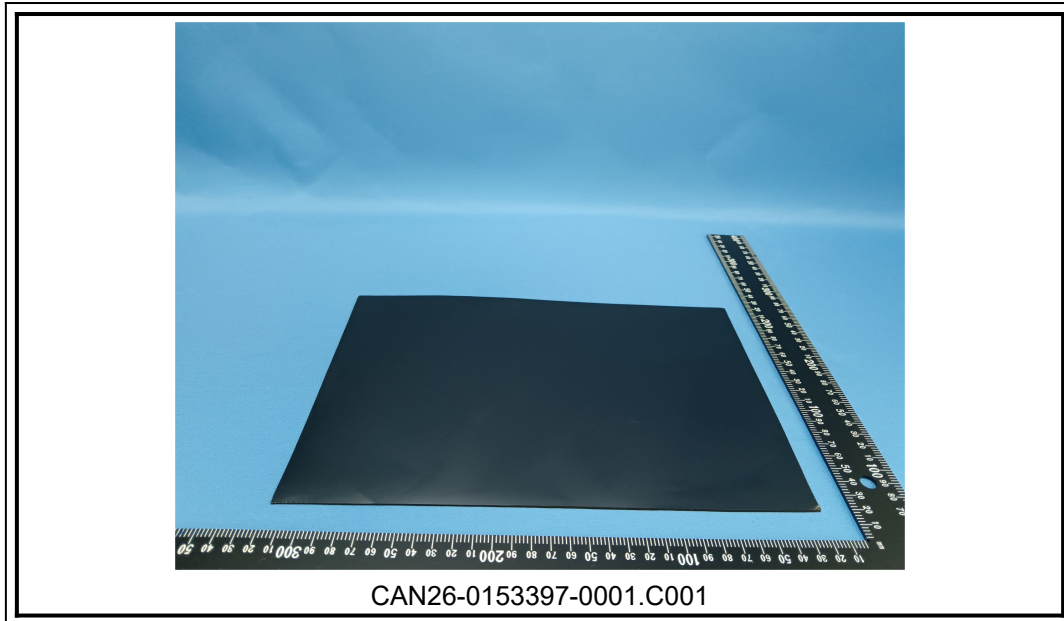
